Description of the item, service, good, or facility provided under the arrangement:

CMS requires that ACOs successfully report on the program's specified quality measures for the ACO and its participants to be eligible for shared savings opportunities. The ACO Board has found that participant activities associated with the abstraction and quality reporting process are necessary for the ongoing operation of the ACO and are consistent with the purposes of the Medicare Shared Savings Program. As such, Wellstar Clinical Partners Medicare ACO, LLC plans to reimburse ACO participants a reasonable amount of each completed chart abstraction, required as part of the first quality reporting period of the ACO contract. Eligible ACO participants will be required to sign an agreement which acknowledges the above and outlines the actual process.
